



RELEASE AND WAIVER OF LIABILITY AGREEMENT

I, the undersigned, acknowledge that I am voluntarily participating in these Sisters on the Fly events.

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN THESE EVENTS, including but are not limited to, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently prepared or trained for participation in these events, and have not been advised to not participate by a qualified medical professional; there are no health-related reasons or problems which preclude my participation in these events. I acknowledge that this Accident Waiver and Release of Liability Form is between myself and the licensing organization, Sisters on the Fly and that it will govern my actions and responsibilities at any and all Sisters on the Fly events I choose to partake in.

In consideration of my registration and permission, as a member in good standing of Sisters on the Fly I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the Sisters on the Fly, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from any and all Sisters on the Fly affiliated events.

(B) I INDEMNIFY, HOLD HARMLESS, AND AGREE NOT TO SUE Sisters on the fly for any and all liabilities or claims made as a result of participation in these activities or events, whether caused by the negligence of release or otherwise. I acknowledge that Sisters on the Fly, its directors, officers, volunteers, representatives, contractors, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of Sisters on the Fly. I acknowledge that these events may involve risks and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, activities you choose to participate in, actions of other people including, but not limited to, participants, volunteers, and event officials.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during these events.

Pet Friendly Events:

I understand that my attendance at a Sisters on the Fly "pet friendly event" is not without risk to myself, my pet, other members or guests, and other event participants (human or animal "pet"). These include, without limitation, risks of physical injury, mental injury, emotional distress, trauma, and death, contact with other participants and their pet(s), and property damage. All risks are known and appreciated by me. I waive any and all specific notice of existence of risks. I shall assume responsibility for and pay my and my pet's medical and emergency expenses in the event of injury, illness, or other incapacity regardless of whether I authorized such expenses or care. I agree that I, as the pet(s) owner, am solely responsible for the pet(s) behavior and physical control and agree to carefully monitor and control it at all times. By signing this document, I hereby waive and release Sisters on the Fly and/or owners of any or all premises on which these events are held, and/or its employees, agents, and volunteers of said organization, and any event organizers, hosts, coordinators, and volunteers of Sisters on the Fly for any and all damages, losses, fines, claims, suits, expenses (including attorney fees and defense costs), judgements and/or liabilities of any form or nature resulting from any act or omission of any pet(s) or pet owners participating in the event. This release of liability includes, but is not limited to, any injury, death, sickness, or personal injury or property damage my pet(s) or I may suffer while on or around the premises where an event is held.

I also agree to defend, indemnify, and hold harmless Sisters on the Fly and our event organizers, hosts, coordinators, volunteers, and/or owners of all premises on which these events are being held, and/or employees, agents, and volunteers of said owners from any and all claims, suits, losses, damages, expenses (including attorney fees and defense costs), judgments, fines, penalties and/or liabilities, due to any and all forms of personal injury (including death) and property damage which my pet(s) or I may have caused, or be alleged to have caused, to any person, animal, or property while on or around the premises where a Sisters on the Fly event is carried out.

All pets and pet owners must adhere to the "Pet Rules of the Road", outlines on the Sisters on the Fly website as well as rules outlined by the property owner of the event's location.

This accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Signing this waiver once covers all Sisters on the Fly and Sisters on the Fly affiliated events for 12 calendar months from the date in which you sign below.

I CERTIFY THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL.
